IOM is committed to a diverse and inclusive environment. Internal and external candidates are eligible to apply to this vacancy. For the purpose of the vacancy, internal candidates are considered as first-tier candidates.

### Context:

Under the overall supervision and guidance of the Director of the Coordination Office for the Mediterranean, Chief of Mission in Italy and Malta, and the direct supervision of the Integration Specialist and Coordinator (PM), the incumbent will be responsible for supporting the implementation of project "PASSIM4 – First Health Assistance for Rescue at Sea Operations" which will be implemented in Catania, Messina, Lampedusa; Crotone and Roccella Jonica.

## Core Functions / Responsibilities:

- Provide general linguistic support and interpretation services to PASSIM4 health teams (doctors and nurses) involved in rescue at sea operations on the Italian Coast Guard patrol vessels in Sicily and Calabria;
- Support the health teams identifying vulnerable groups among the migrants rescued by the PASSIM 4 interventions;



- Remain available to participate in rescue operations at sea on the Italian Coast Guard patrol vessels, as required by the PASSIM 4 team;
- Participate in all the training sessions envisaged by the PASSIM 4 project (i.e. health assessment, psychological first aid, gender-based violence, human trafficking, intercultural communication, stress management and burn-out prevention);
- Support the PM in reporting on any issue related to migrants rescued to be provided within the PASSIM 4:
- Support with any relevant administrative and procurement procedure to be implemented locally in Sicily and Calabria (Lampedusa and Catania, Messina, Crotone and Roccella Jonica);
- Any other related services, as requested.
