ANNEX 1: SCHEDULE OF REQUIREMENTS

Through the following call for quotation, the International Organization for Migration (IOM) - Rome Mission - plans to select a legal expert to ensure that the principles of transparency, adequate notification, and equal treatment are correctly applied in the selection processes for the contractors, either natural or legal persons, who will carry out all project activities related to the A.L.T. Caporalato D.U.E. project, funded by the Ministry of Labour and Social Policies under the Migration Policy Fund, for the period 1 December 2022 - 30 November 2024.

In particular, according to the art. 12 of the partnership agreement between National Labour Inspectorate (INL) and IOM aimed at the implementation of the project, IOM undertakes to identify, through a specific selection procedures, an external subject qualified and authorized to carry out administrative and accounting audits in Italy, in charge of the monitoring and the half-yearly verification of the expenses incurred by IOM.

The legal expert will be responsible of the following main activities:

- a) review all necessary documents proving the procedures followed to entrust third parties with the implementation of certain project's activities;
- b) request and provide IOM with clarifications on the documentation as per point a) as needed;
- c) issue 3 interim legal reviews and reports and 1 final legal review and report according to the following deadlines:
