Asylum - National Objective ON1 - letter d), year 2022, project code PROG-3833, for the period 1 November 2022 – 31 July 2023.

In particular, the Implementing Regulation (EU) No. 840/2015, which highlights the controls carried out by the Responsible Authorities under Regulation (EU) No. 514/2014, states, "As provided for in Article 1 C) 3. of the Implementing Decision 2008/458/EC, that the Responsible Authority may require that the Beneficiaries have an Auditor for the verifications aimed at confirming the formal correctness and mathematical accuracy of the financial statements, as well as for the verifications of the accuracy of the financial statements

The Auditor must comply to the terms of the Agreement, which has been signed by the Responsible Authority and the Beneficiary, to national and international laws, as well as to the operational guidelines and rules that the European Commission and the Responsible Authority had also established for the implementation and verification of funded projects.
